Fosterer agrees to the following:

1. Fosterer acknowledges that Ownership of any animal being fostered is not transferred from Malinois and Dutch Herder UK Rescue and that the animal must be immediately relinquished to MADUK Rescue on request.
2. Fosterer can terminate this agreement at any time and agrees to give at least 7 days written notice of intent to do so unless in an emergency.
3. Fosterer undertakes not to post any photos, videos, comments or other information regarding the animal or the rescue on social media in any form.
4. Fosterer agrees to provide written updates to MADUK Rescue as required and instructed.
5. No trainers or behaviourists will be consulted by the Fosterer or their advice used or followed without the written agreement of MADUK Rescue.
6. No laypersons advice or suggestions will be used by or followed by the Fosterer.
7. Fosterer agrees to allow MADUK Rescue onto or into their premises where the animal is being kept at any time to ascertain and satisfy itself that the animal is well cared for.
8. Fosterer agrees not to alter in any way the appearance of the animal including de-clawing, ear cropping, tail docking or other procedure unless instructed by a vet and with the agreement of MADUK Rescue.
9. Fosterer agrees to provide safe and suitable care, feeding and shelter for the animal and not to cause the animal any pain, suffering or distress.

10. Fosterer will notify **MADUK Rescue** of any behaviour changes, behaviour of concern, illness or injury immediately. **MADUK Rescue** reserve the exclusive right to determine any course of action needed.
11. Fosterer will notify **MADUK Rescue** immediately of any change of contact details, intended change of address or other relevant factors such as household members changing.
12. Any specific requirements relating to the animal as included in appendix 1 will be followed absolutely.

MADUK Rescue Responsibilities:

- **MADUK Rescue** will have suitable insurance in place during the period of any foster contract.
- **MADUK Rescue** will provide full history of any animal offered for foster and give specific written instructions for each animal individually.
- **MADUK Rescue** will remove any animal where an emergency has occurred as soon as practical.
- **MADUK Rescue** is responsible for veterinary treatment costs where not caused by any negligence on the part of the foster carer.
- **MADUK Rescue** will provide an emergency contact number and email address.
- **MADUK Rescue** is responsible for all costs of food, equipment and veterinary attention for illness or accident except in the case of fosterer negligence.
- **MADUK Rescue** will advise the fosterer of any concerns during the foster contract period and endeavours to give 14 days' written notice of termination of foster contract where possible.

In consideration of the premises, it is agreed between the rescue and Fosterer as follows:

- The rescue will perform home-checks, and vetting, before any person is accepted as a Fosterer.
- Safe transportation will be arranged for the animal in question to the address above.
- The animal will reside at the address above only and must not be held elsewhere permanently or temporarily without the written permission of **MADUK Rescue**.

If the foster animal is a dog, the Fosterer agrees to the following rules:

- The dog must wear a collar harness and tag at all times in public to comply with the law
- The dog must be kept on a lead in public at all times
- Any specific equipment identified in appendix 1 will be used

Additional Conditions:

- This agreement is entered into voluntarily by the Fosterer who is aged over 18.
- Fosterer is undertaking these obligations with no claim, now or in the future, to any type of compensation or reimbursement for caring for animal in question.
- Fosterer accepts that whilst every effort is made to inform you of the animal's history and good practice to follow, that accidental animal bites or other injuries to humans and other animals do occur.

MADUK Rescue will not be liable if said animal should damage or destroy property belonging to Fosterer should the fosterer not follow advice.

This agreement is the entire agreement of all parties, and there are no oral promises or representations made in addition to the contract and it may only be changed in writing signed by MADUK Rescue and fosterer.

MADUK Rescue retains the right to terminate this agreement and reclaim/remove the animal immediately should they have any concerns about the welfare of the animal or any conditions have been breached by the Fosterer.

The fosterer undertakes to give 14 days written notice of intention to terminate the foster contract unless an emergency occurs.

 - A dog gate must be fitted permanently to allow the dog safe space when visitors are allowed to come and to ensure separation from visitors and to prevent the dog from reaching the front door when opened.
 - The dog is to be placed behind this gate when any visitor comes.
 - The animal must be kept separately from other pets/animals/people for a minimum period of.....eg a week..... And afterwards introduced with the permission of **MADUK Rescue**.
